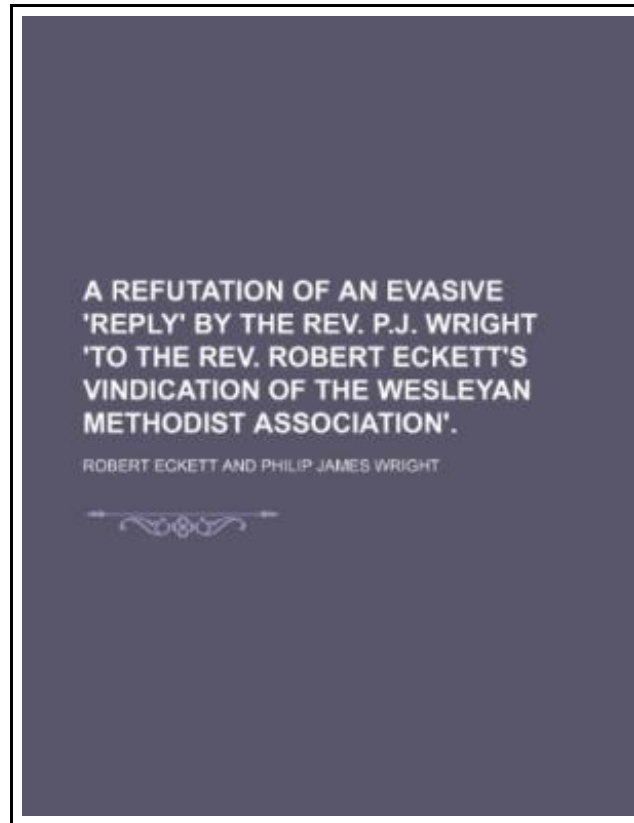

Mr. Wright says-- The New Connexion was willing to change the name as soon ns it could be done with safety. He then proceeds to describe the impediment to the change as having been exclusively of a legal nature. Now if Mr. Wright had put the word legal before the word safety,...
